This area also includes an interest in the problems in transforming government-owned banks into joint stock companies and reconverting banking foundations. Conducted in-depth analysis of several aspects concerning the management of banking foundations and the definition of their target function. In another area, she studied several issues relating to solidarity in financial intermediaries' operations, social reporting and the wider issue of reputation risk.

5) Several aspects of relations between banks and insurance companies. The investigation focused on an in-depth analysis of distribution problems and relations between banks and insurance companies within multi-function groups and financial conglomerates, on the one hand.
